

The inspection of above said school was got carried out by the inspecting officer of this department. During inspection it was found that the management has installed Hose Reel Hoses and First Aid Fire Extinguishers in their school premises, besides this one underground water storage tank of 12 KL capacity is also available. The school is about 02 Km away from Fire and Emergency Station Akhnoor Jammu and is approachable for fire appliances in case of any emergency. Since the school is already functioning, as such, the management can proceed ahead for operation subject to strictly adopt the following fire safety precautionary measures in letter and spirit forthwith:-

01 No. Clean Agent Type Fire Extinguisher of 02 Kg capacity should be provided in computer room and 01 No. of CO<sub>2</sub> Type fire extinguisher of 4.5 Kg capacity should be provided near main electric switch board panel in addition to already existing fire extinguishers.

All exits/entrances should be kept open and free from any obstruction for easy

and safe evacuation of inmates during any emergency.

First Aid Fire fighting system installed in the school building should be checked periodically. Staff and students should be fully trained in handling / operating of fire fighting system installed in the school building. The management shall intimate this office in writing after each quarter that the fire fighting equipments installed in the school are functioning.

All class rooms and examination halls having seating capacity for more than

45 students need to be provided with two exits.

The corridor of the building shall not be used for any kind of storage.

No Hazardous material should be kept inside of the school premises (especially LPG cylinder, Petrol and Diesel etc.). Any deviation found in this regard, this clearance will be treated withdrawn/cancelled.
